Item No 56.7.1:

The members deliberated over the issue. It was unanimously decided that Dr. Govind Bhargava, Ex-Registrar, NIT Agartala should get his pension at the earliest. Board decided that Dr. Bhargava will get his pensionery benefits from BOAT Kanpur as per decision of the Board of Governors of NIT Agartala taken in its 48th meeting against Item No. 48.9. In this respect the Ministry officials were requested to take up the matter with BOAT and clear the issue with BOAT, Kanpur to release his pensionery benefits and the officials agreed to resolve at the earliest.
