- (ii) In connection with Sl.No.10 (25.8.4): A letter may be written to the Government of Tripura with a copy to MHRD elaborating the problems faced by NIT Agartala on TVAT matters and double taxation. If necessary, legal opinion may be obtained. The Board members noted that the same double taxation are not charged to the Institutions under the control of the Government of Tripura.

Addl. Item No. 26.11:

To consider the detailed project-report for construction of 100 bedded hospital with trauma centre alongwith research facilities with the preliminary cost estimate of Rs. 235.50 crore.

The construction of 100 bedded hospital with trauma centre was initiated as per suggestion of the Ministry of HRD and placed in the 19th BWC meeting held on February 12, 2011. The Finance Committee discussed this matter in its 14th & 15th meeting and recommended for preparing detailed project report etc. The recommendations of the Finance Committee were also approved by the BoG in its 17th meeting. Keeping all these in mind, NIT Agartala has prepared a detailed project proposal for construction of 100 bedded hospital with trauma centre along with research facilities. The State Government of Tripura agreed to provide land for the hospital adjacent to NIT Agartala campus and bear 10% cost of the construction of the hospital. NIT Aartala plans to start a course in Medical Engineering. A course in Bio-Engineering has already started from the academic year 2012-13. Creation of such facilities might be useful in running these courses.

The proposal for construction of 100 bedded hospital with trauma centre along with research of facilities with a preliminary cost estimate of Rs.235.50 crore may be sent to the Ministry of HRD, Govt. of India, for onward transmission to the Ministry of Health & Family Welfare, Government of India, for consideration.




