





The Building and Works Committee approved the proposal to award the balance work of the said lift well to the CPWD as deposit work along with the installation of other lifts of the institute.


To consider approval for the work of "Supply, installation, testing & commissioning of 14 (fourteen) lifts in Administrative Building 1 & 2, School of Management, International Guest House, Academic Block (ECE Deptt. & DoNER) and Central Library at NIT Agartala" at a cost of RS. 4,17,13,490.00.

The BWC had considered the proposal for installation of lifts in the newly constructed buildings of NIT Agartala in its 35th meeting held on 10th Feb' 2016 for "Supply, installation, testing & commissioning of 14 (fourteen) lifts in Administrative Building 1 & 2, School of Management, International Guest House, Academic Block (ECE Deptt. & DoNER) and Central Library at NIT Agartala" for open tendering based on the estimate prepared by the Institute at a cost of Rs.2,67,34,665. In this respect several attempts have been taken to take up the works after calling of open tender but no fruitful outcome has yet been achieved. The buildings are already functional. It has been a very tedious task to climb fourth floor and above for PwDs and elderly person. Considering the urgency of the work and in the event of not being able to select the suppliers in spite of taking three attempts, it is opined by the Institute that the work may be awarded to the CPWD as deposit work and CPWD was also requested to submit a cost estimate for the above work. In response CPWD has submitted an estimate amounting to Rs. 4,17,13,490.00 including 3% contingency charges (rates are based on present market rates). The estimate submitted by the CPWD includes civil works such as construction of Lift Pits in Academic Block (DoNER Building), wall cladding of lift lobby of different building at NIT Agartala and Comprehensive Annual Maintenance of 14(fourteen) nos. lift for one year. For the said reason the estimated cost have been increased from Rs. 2,67,34,665.00 to Rs. 4,17,13,490.00. Earlier estimate was prepared by the Institute considering market rate of 2012, whereas the cost estimate submitted by the CPWD is based on the prevailing market rate.

The matter has been discussed in the meeting of 38th Building & Works Committee held on 15th March 2017. The buildings are already functional. It has been a very tedious task to climb the 4th floor and above for the PWDs and elderly persons.

The BWC approved the proposal for awarding the work of supply installation, testing and commissioning of 14 (fourteen) nos. Lifts to CPWD as deposit work at a cost of Rs. 4,17,13,490.00. The Committee also recommended the proposal to FC and BOG for consideration and approval.

The work of "HVAC, Stage Craft, Stage Light, Sound System, Project System, Sitting Arrangement etc. in seminar Hall at NIT Agartala" is very essential to be done as the Seminar Hall could not be utilized without the above facilities. Institute felt that the work may be awarded to the CPWD as deposit work who has been working in other construction work of NIT Agartala campus and has the potential to complete the work within the time frame.

The matter has been discussed in the meeting and approved and confirmed by the Building & Works Committee (BWC) that the work may be awarded to the CPWD as deposit work and it is also suggested by the Building & Works Committee (BWC) that the CPWD to be requested to submit cost estimate of the said work.

Item No. 38.8.4:

To consider the proposal for installation of 14 nos Thyssen Krupp (India) Pvt. Ltd. Make 13 passenger capacities lift for construction of 1500 capacity Boys Hostel of NITA.

One 1500 capacity mega Boys hostel is under construction at NIT Agartala. It comprises of 7(Seven) Blocks G+7. As per provision of BOQ in each block 2(two) nos,13 passenger capacity lifts are to be installed. Thus, in total 7x2 = 14 (fourteen) nos lifts are to be installed. M/s. NCC Ltd. is the construction agency.

Thus, M/s. NCC Ltd. has offered a pre-dispatch inspection of 14 nos of 13 person capacity passenger lifts of approved make of Thyssen Krupp (India) Pvt. Ltd.(TKEI) as per the contract Agreement Part-I, Volume I of III, Page No. 120, Clause No – 10.2 read with Clause No 1.1 of Page No. 198.

Accordingly, 2 (two) officials of NIT Agartala were deputed for inspection of the materials as specified in the Agreement. As per type test report of one item (product design code – TK5A, Hollow Guide Rail), it is noted that the product is non-standard guide rail, it does not meet the requirement of the standard JG/T 5072-3-1996.

However, as per literature available there is no IS standard for TK5A hollow guide rail which is confirmed by the Thyssen Krupp (India) Pvt. Ltd. However, in ISO 7465 – 2007, clause – 6.2.2 (Table No-2-7) it is specified that Guide rails with other dimensions can be delivered on specific agreement between the guide rail manufacturer and the customer. Subsequently, Thyssen Krupp (India) Pvt. Ltd has stated that the dimensional requirement for TKEI is as per their product requirement. So, it required to be designed accordingly (other than dimensional specification elaborated in JG/T 5072, 3-1996) and all tests were carried out as per JG/T 5072, 3-1996. It is noted from the type test report that the parameter tested as per the standard JG/T 5072.31996 has passed.

As per standard JG/T 5072.31996, tensile strength should not be less than 370 MPa whereas the test result is 469 MPa which is much higher than the specified standard limit. As per the technical document review the guide rail materials and design standard or design drawing is also passed.

Thyssen Krupp (India) Pvt. Ltd. has submitted an undertaking where they have assured and warrants its best services regarding hollow guide rail performance and quality related matter.

From the above, it is clear that all the parameters are in order as per standard JG/T 5072.31996 and only dimensions are different which do not have ISO specification. NIT Agartala has earlier installed 10 nos Thyssen Krupp (India) Pvt. Ltd make lift in the campus building which are functioning satisfactorily since the year 2014.

The matter was placed in the 38th BWC Meeting held on 15-03-2017, for kind consideration and after threadbare discussion the Building & Works Committee (BWC) has approved and confirmed the proposal to give clearance to the NCCL to dispatch of the lift allied materials in respect of the installation of "14 nos Thyssen Krupp (India) Pvt. Ltd. make 13 passenger capacities lift for construction of 1500 Capacity Boys Hostel of NITA". The Building & Works Committee (BWC) also suggested that 2 (two) year guarantee certificate, shall be obtained from the NCCL for the 14 (Fourteen) lifts.
