Item No. 24.1: Confirmation of the Minutes of 23rd Meeting of the Finance Committee held on February 27, 2014.

Item No. 24.2: **Action taken on the decision of the 23rd Meeting of the Finance Committee held on February 27, 2014 in the Conference Room of NIT Agartala.**

The action taken report noted.

Item No. 24.3: **To consider the Financial Status of the Institute as on April 25, 2014.**

The Finance Committee noted the present financial status and requirement of fund under Plan and Non-Plan schemes.

Item No. 24.4: **To consider the Annual Budget of the Institute for the year 2014-15.**

The Annual Budget for the financial year 2014-2015 of NIT Agartala (Plan outlay - Rs. 35700.00 lakhs and Non-Plan outlay - Rs.8050.00 Lakhs) was perused and approved by the Finance Committee with the following observations:

- (A) Under the Plan outlay, fund requirements are to be prepared in two categories viz- Immediate and Priority. The works which are in the final stage of completion shall fall under immediate category. Remaining works / procurements will be falling under priority basis. The priority works could be taken up depending upon the availability of fund from the MHRD to NITA on quarterly basis.
- (B) Salary projection under the Non-Plan Head should be utilised only for salary on actual expenses basis.

Item No. 24.5: **To consider the Physical & Financial Statement of the ongoing construction works/ projects.**

The Finance Committee noted the progress of the works with the following observations:

Buildings which are in advance stage of completion are to be completed and put in use immediately as noted under Item No. 24.4. Furnishing of the completed buildings are to be done on priority basis. Director, NITA may review the individual work time to time. In some cases the fund requirements for on-going projects are projected on higher side and that might be worked out on realistic basis. Prioritizing the new projects, works could be taken up depending on the availability of fund from the MHRD.

Item No. 24.6: **To consider the Medical Reimbursement Claim for Rs. 1,96,269/- of Dr. Rabindranath Barman, Asstt. Prof., PE Dept., NIT Agartala in connection with treatment of his wife.**

The Finance Committee approved the proposal of reimbursement of the medical claim of Dr. Rabindranath Barman, Assistant Professor for undertaking treatment in private hospital as a special case limiting the claim up to the CGHS rate available for undertaking such treatment in reference to the Government of India, Ministry of Health and Family Welfare, Department of Health & Family Welfare, Office Memorandum No.Z.15025/5/2011-CGHS III/CGHS(P),

dated 22nd November, 2011. The NITA should work out the claim as admissible under the CGHS rate and settle the claim accordingly.

Item No. 24.7: **Sanction of an amount of Rs. 25,454.00 (Rupees twenty five thousand four hundred fifty four) only from TEQIP-II towards cancellation charges for air fare.**

The Finance Committee observed that the proposal for reimbursement of cancellation charges of air fare for an amount of Rs.25,454.00 is not admissible.

Item No. 24.8: **Present Status of TEQIP-II Project of NIT Agartala.**

Dr. Ardhendu Saha, Coordinator, TEQIP-II Project, made a presentation on the present status of TEQIP-II Project of NIT Agartala. The Finance Committee noted the present status of the TEQIP-II project.
