



**Amendment to Memorandum of Understanding  
Academic and Research Collaboration**

**between**

**National Institute of Technology, Agartala, Tripura, India**

**and**

**Indian Institute of Technology, Hyderabad, Telangana, India**

National Institute of Technology, Agartala (NITA) and Indian Institute of Technology, Hyderabad (IITH) have entered into Memorandum of Understanding (MoU) dated 21/06/2022. The following amendments are made to the said MoU:


