

2.0 Details of e-tender document.

The National Institute of Technology Agartala (NITA), an Institute of National Importance(INI) was instituted by Government of India with the mission to herald excellence in technical education and research in the North-East region. The institute was established by the Ministry of Education (MoE) in the era of renaissance in technical education in north-east. NIT Agartala, in its strategic initiatives realizes the responsibilities of higher education to meet the future challenges of a sustained development in knowledge-based economy and roots its commitment in inculcating the values of quality education as per National Education Policy 2020 (NEP2020).

2.1 Scope of Work:

Bid is invited from Telecom Service Provider (TSP)/ Internet Service Provider (ISPs) of Govt. PSUs for Provisioning of 1 Gbps Internet Connectivity at National Institute of Technology Agartala (NITA).

2.3 Eligibility Criteria:

- > The solution providers/ firms interested in the tender must be registered in India.
- ➤ Balance Sheets/Annual Reports along with tax audited balance sheet and other financial statements for last three years must be submitted.
- ➤ Bidders should submit the proof of having experience of executing minimum 3 Multiprotocol Label Switching (MPLS) orders from Central Govt. /State Govt./PSU/State or centrally funded autonomous bodies.
- > Copy of Certificate of Incorporation.
- > Detailed methodology for undertaking the solution.
- > Compliance of the solution with the International/National Practices/ Standards.
- > Past experience and Profile of the organisation.
- The bidder should have a dedicated network management system (NMS) for troubleshooting round the clock (24X7) to ensure uninterrupted services. The NMS should be manned 24 x 7 and have call logging and escalation procedures. Calls can be logged through a dedicated Mobile/landline No, web based or email.
- Liasioning (if required) with other firm(s) for obtaining point to point connectivity between ISP node and NIT Agartala shall be the responsibility of quoting firm.
- The ISP should be Govt. PSUs and have a valid Category an ISP license from Govt. of India (Attach a copy of license).
- > ISP must have DOT license to set up and operate gateways. ISP must have distributed minimum 10 Gbps of Internet bandwidth to its clients (Attach certificate).
- The quotation should clearly indicate the different components of the total charges- recurring (annual) and non-recurring (one time) for bandwidth and equipment supplied along with mode of payment i.e. whether quarterly / half-yearly / annual or one time (if any).
- > Compliance of terms with any deviation should be clearly indicated in remarks in separate deviation sheet.
- > The ISP should have a fully functional Customer Service Centre in North East India which is operational 24 hours. (Attach Certificate)
- The bidder would ensure that the local loop provisioning does not violate regulations as laid by Government of India/TRAI in respect of such links/networks. Bidder will be responsible for making all the payments towards the local loop charges/rentals charges etc.

- > The solution providers/firms should submit the quotation in two bid system, i.e., technical bid and Commercial bid. Commercial bid of those solution providers/firms will be considered who will qualify technically.
- > The NIT Agartala reserves the right to carry out the capability assessment of the bidder and the NIT Agartala decision shall be final in this regard.
- > The firm must mention clearly the requirement of Hardware and Software (server, operating system, switch etc.) from NIT Agartala to make this Internet connectivity operational.
- > The solution providers/ firms not complying with above conditions or not providing complete information as described shall not be considered.

3.0 Performance Measurement:

- > Uptime: Minimum network uptime has to be 99%. This time will be calculated daily before releasing the payment.
- ➤ Latency: The maximum allowable latency shall not exceed 20 mili second.
- > Throughput: The minimum throughput has to be 90% of the speed prescribed for each link.

3.1 Performance Penalties:

➤ Uptime Penalties: In case the uptime falls below the guaranteed level, following penalties will be imposed.

- > Latency Penalty: In case latency falls below the guaranteed level, NIT Agartala will impose a penalty of 5% of the total amount for each link.
- > Throughput: In case the throughput falls below the guaranteed level, NIT Agartala will impose a penalty of 5% of the total amount for each link.

4.0 Termination of contract:

The agreement contract period will remain valid for next five (05) years with effect from __/_/2025 with yearly renewal basis which is based on the performance of the ISP. However, in case of continuing failure to maintain the service levels, the client can terminate the contract after giving adequate opportunity to the consultant to explain the failure and rectify the failure within a maximum period of one month.

Estimated cost:

- Rs. Seventeen (17) Lakhs /yearly (approximate).
- > The service charges shall be paid on quarterly basis.

4.1 Responsibilities under the contract:

The ISP would be responsible for the following:

- > To provide 1 Gbps Internet connectivity (Leased Line) at NIT Agartala. Internet Router Port at ISP Gateway for required Bandwidth and minimum fourteen (14) IP addresses including Reverse Lookups configured at these IP's.
- ➤ Liasoning with BSNL/Railtel/PGCIL for obtaining point—to-point connectivity between ISP node and NIT Agartala.
- > Installation, commissioning, configuring of the link and hardware (Mux, Modems and Router etc).
- Maintenance support service (24 hours and 7 days a week) for bandwidth and equipment.
- > 14 nos. of public IPs should be provided free of cost.

5.0 ISP will be required to sign Service Level Agreement having the following:

- > 1 Gbps Internet bandwidth at all the time.
- > Packet Losses: Less than 1% (Average over 1000 ping) at any given point of time to any part of globe.
- Latency: Less than 20 ms from NIT Agartala to ISP's tier1 peering point.
- Network Availability: More than 99.0% per month.
- > Reports for performance, monitoring /usage to be submitted by the ISP on weekly or monthly basis or as per requirement of NIT Agartala.

Also, if services are not found satisfactory, NIT Agartala reserves the right to cancel the contract with one-month notice.

7.0 Special Terms & Conditions:

- 7.1 The rates quoted by the Supplier/Bidders should preferably be on basic price and GST.
- 7.2 All taxes and duties will be paid extra and such amounts of mandatory/statutory taxes & duties shall be explicitly mentioned in BOQ while submitting of bid. If GST amount not quoted in the BOQ (price bid), the total cost will be treated as inclusive of GST.
- 7.3 Price has to be filled through CPP portal as per BOQ (https://www.eprocure.gov.in). The scanned copy of Price Bid, dully filled in, has to be uploaded on the above e-procurement site. The prices filled in the e-procurement site will be treated final and shall be binding to the vendor.
- 7.4 The bidders who are registered as a Micro or Small Enterprise as per latest definitions under MSME rules, Govt. of India for exemption of submitting EMD/Bid security must enclose relevant documentary proof of authentication of their firm's registered as a Micro or Small Enterprise as per latest definitions under MSME rules, Govt. of India.
- 7.5 If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria".
